Limited Leave to Remain in the UK.		Indefinite Leave to Remain in the UK.
Absences longer than 180 days in any 12-month rolling period might make you lose the right to apply for settled status. However, there are exceptions to this rule – please get in touch if you need assistance.		Can be absent from the UK for up to 5 years in a row without status being affected.
Limited, or no access to public funds (local authority housing support, Universal Credit, Child Benefit etc.)		Same access to public funds as British Citizens.
Children born in the UK to parents with pre-settled status will have to apply to the EU Settlement Scheme to get their own immigration status.		Children born in the UK to a parent with Settled Status will automatically become British Citizens
Cannot apply for British citizenship with pre-settled status.		May be able to apply for British citizenship (if all the relevant criteria are met).
